MOBILE EDUCATION VAN PROJECT

The Mobile Education Van Project covers 60 villages from 4 blocks of Bharuch district. The project addresses educational needs of the out of school and in-school children both from 38 villages of Ankleshwar block, 17 villages of Jhagadia block, 4 villages of Hansot block and 1 village from Valiya block. The project is being led by Mrs. Meeraban Panjwani as the Convenor.

A total of 6304 children are benefitted of which 3062 are girls and 3242 are boys. The project did not reach out to children during the year under consideration on account of the covid pandemic and adherence to the government guidelines.

Under the guidance of Mrs. Meera Panjwani, the team of mobile education van project initiated Adult Education intervention with support from 17 teachers from September 2021. These teachers went to the residences of those who were interested in learning. They helped them learn in small groups through guided group interactions by abiding to the government pandemic protocols

The efforts were recognised by GTPL News Channel through an interview of Mrs. Meera Panjwani regarding the adult education intervention. A teacher Mrs. Falguni Jani and two beneficiaries of the intervention Mrs. Maniben and Mrs. Sitaben were also interviewed. Mrs. Meera Panjwani who has been associated with the Rotary District Literacy Program since 2014, taking initiative turned the pandemic situation to an opportunity to offer adult education to 66 persons through this intervention. These 66 adults are now able to read and write and have gained functional literacy.

Not only the mobile education van staff has served as volunteers at the covid vaccination center operational at the D. A. Anandpura Cultural and Sports Centre, but also have helped the children living nearby their own residences to learn, grow and develop during the lockdown periods. They also went to the extent of providing their own smart phones for educational purposes to such children in need.

About the hospital :

Serving the healthcare needs of the industrial town of Ankleshwar since 1986, Smt. Jayaben Mody Hospital has gracefully completed its thirty-five years of operation this year.

With the development of GIDC Ankleshwar in 1970-80's there was a great need for healthcare for the staff and workmen of this area. There was no government hospital in this area to provide for medical facilities. On 14th October, 1981 the Ankleshwar industries Association set up an OPD dispensary along with an ambulance service to cater to the immediate health needs of the local people in GIDC Housing quarters and later in 1983, the Ankleshwar Industries Association sponsored a public charitable trust named "Ankleshwar Industrial Development Society".

Mody family that was running the Unique Group of Companies at Ankleshwar, felt the need for bringing healthcare facility within the reach of the common people and the tribal population of the surrounding areas, who cannot afford and travel to urban centers for availing expensive medical aid. And thus, being a philanthropist and visionary, the family donated towards setting up of the hospital in memory of their mother late Smt. Jayaben Mody.



With the initial donation a twenty-five bedded hospital was started in the GIDC housing quarters which became a full-fledged hospital in 1996. The hospital was inaugurated by the then Chief Minister of Government of Gujarat Shri Suresh Mehta in the presence of Swami Shridharanandji, President Ramakrishna Mission Lucknow. Gradually the hospital has developed into a 140 bedded full-fledged, multi-speciality hospital with all essential amenities and facilities.

The Gujarat Industrial Development Corporation (GIDC) was instrumental in providing the land free of cost to build up the existing modern and well-equipped hospital with best accessibility advantage on the Ankleshwar Valia State Highway No. 13, which is just a 10-minute walk from railway station as well as the bus depot. The hospital serves not only the population of Ankleshwar city, the industrial estate and Bharuch city, but also to the sub-urban, rural areas and tribal hamlets in the entire region.

Currently Smt. Jayaben Mody Hospital, with a current bed strength of 140, a full-time medical team of fourteen specialists, visiting doctors' team of twenty specialists, supported by well-trained, qualified nursing and paramedical staff, operations and administrative team; is dedicated to deliver quality medical care to all its patients. The hospital also offers round the clock services of an emergency department, a well-stocked medical store and ambulance services at nominal cost.

Making wellness a way of life, this hospital is dedicated to the service of humanity, be it in the times of trauma or paving way towards lifestyle changes for a healthy and happy living.

The intensive care unit (ICU) at Smt. Jayaben Mody Hospital rated as the most affordable and best quality care providing ICU of the entire Bharuch district has 6 critical care beds fully equipped with state-of-the-art medical equipment, well-trained and caring staff for the treatment of patients who need continuous monitoring and support. The neonatal ICU is also equipped with ventilators.

The hospital has 21 ventilators with central oxygen supply backed by 5 oxygen generation plants, continuous patient monitoring system and a six bedded burns ICU too.

● Oncology

Smt. Jayaben Mody Hospital is one of the foremost hospitals in Bharuch district to provide oncological services to the community at large. The hospital has been providing chemotherapy as per the prevailing medical guidelines and protocols. Keeping the affordability of patients as well as with the service objective in view, the chemotherapy medicines are being provided to all the patients at 50% discounted rates.

● Nutrition Facility

Nutritive food plays a vital role in promotion and preservation of health. - **Trauma Centre & New Gynec ward**

Smt. Jayaben Mody Hospital signed an agreement M/s. K Patel Chemo Pharma for Rs. 51 lacs for the construction of trauma center.

With the substantial donation of Rs. 15 lacs from Ratnamani Bio-Chemicals & Pharmaceuticals Pvt. Ltd. and Rs. 11 lacs from Subhasri Pigments Ltd. through Shri K. Srivatsan, a new gynec ward & an operation theatre has been constructed and will be operational soon.

- **Cancer Radiation Centre**

The hospital initiated OPD services, operative facility and chemotherapy services for the cancer patients since last four years as there was no such facility across Bharuch district then. The patients had to go to Vadodara, Surat or Ahmedabad for their surgical treatment and radiation. To provide a more comprehensive cancer treatment, to reduce the treatment time, travel time and cost of the patients; the hospital envisaged the establishment of a modern cancer radiation center.

This noble thought was given a great push towards realization with the Mody Family and Unique Group of Companies providing funds to the tune of Rs. 8 crores. The total cost of the project is Rs. 26 crores. The major cost is for radiation machine at Rs. 12.2 crores and 3.3 crores duty/GST. The balance is for bunker to be provided and other facilities. The hospital is importing machines from Varian USA - Vital Beam with all attachments which can treat 97% of the patients at the Hospital itself.

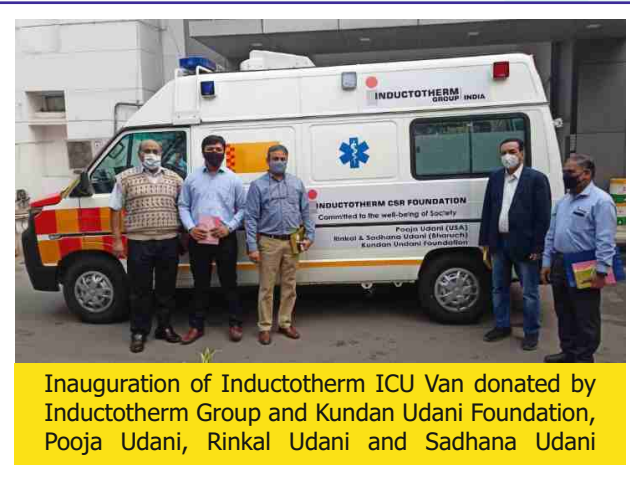

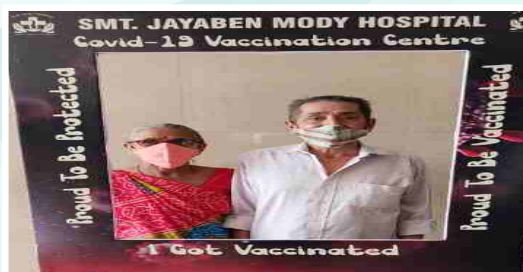
Shri. Mukeshbhai Patel

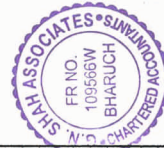

With the support of his family, he initiated Ansuya J. Mody Women Empowerment Project and trained more than 3000 women and supported them to be self-sufficient and earn family income. He was not only a philanthropist but also spearheaded the development of pharmaceutical industry in the country. He was the founder member of Indian Drug Manufacturers Association (IDMA). Shri Dineshbhai Mody was the founder president of Pharmexcil. It is a great loss to the industrial community of Ankleshwar as well as AIDS that we lost two stalwarts within a span of one year.

With the support of his family state-of-the-art Cancer Radiation Centre is coming up at Smt. Jayaben Mody Hospital at the cost of 26 crores.
